# **CAMPAIGN TERMS AND CONDITIONS:**

1. This Campaign is open to new and existing clients of Ultima Markets. By participating in this

Campaign, clients acknowledge that they have read and agreed to be bound by the Terms and

Conditions herewith and Ultima Markets' General Terms and Conditions.

2. To become a new client of Ultima Markets, it is necessary to register with Ultima Markets,

provide all relevant information upon request as part of "KYC" (Know Your Customer) process

and create a Live Account.

- 3. The Campaign is applicable to Live Account only.
- 4. This Campaign will commence on 1st July 2024 00:00 (GMT+3) and ends on 1st July 2025 23:59 (GMT+3).
- 5. To participate, clients must opt-in via designated promotion section in the Ultima Markets' client portal and initiate a deposit into their Live Account during the Campaign period.
- 6. Any internal transfers in between accounts are not considered deposits for fulfilling the requirement of participating in this Campaign.
- 7. During the Campaign period, the Client's trading order that was closed with profit will be
  - rewarded with an additional 1% of the trading order's total profit, minus commission, and other

(GMT+3).

8. All orders will be calculated based on total profit and loss at around 05:00 (GMT+3) daily.

9. Clients with accounts linked to PAMM and MAM will not be able to participate in this campaign.
