 - Registration Period: 1 October 4 December 2023 (all dates inclusive)
 - Competition Period: 10 October 15 December 2023 (all dates inclusive)
- 2. This Competition is open to both new and existing Ultima Markets clients with residence registered from selected countries/regions only as indicated below. New clients must open a new live account with Ultima Markets (meaning, not a "demo" account).
- 3. By participating in this Competition, clients acknowledge that they have read and agreed to be bound by these Terms and Conditions and the Client Agreement as published on the website of the Company.
- 4. Clients are required to fulfill the following actions to qualify and participate in this Competition:

- · Initial equity: Account equity at the time the participant joins the competition on
- Initial deposit: Deposit made at the time the participants join the competition
