# **CAMPAIGN TERMS AND CONDITIONS**

## **DURATION**

This Campaign is valid from 7th April 2025 00:00 (GMT+3) to 7th May 2025 23:59 (GMT+3).

## **ELIGIBILITY CRITERIA**

1. This Campaign is open to all new clients of Ultima Markets. By participating in this Campaign, the client acknowledge that they have read and agreed to be bound by the Terms and Conditions herewith and Ultima Markets’ General Terms and Conditions.
2. To become a new client of Ultima Markets, it is necessary to register with Ultima Markets, provide all relevant information upon request as part of “KYC” (Know Your Customer) process and create a Live Account.
3. A new client is defined as an individual who has never registered for a live trading account with Ultima Markets before March 1, 2025, and whose application has been accepted by Ultima Markets. Ultima Markets reserves the right to independently assess whether the applicant has any association with other existing account holders of Ultima Markets, including holders of previously closed accounts, to determine the applicant's eligibility as a new client.
4. This Campaign is applicable to all types of Live Accounts.
5. To participate in this Campaign, clients will be required to opt-in via designated Landing Page or designated promotion section in the Ultima Markets' client portal.
6. New clients are required to register an account with Ultima Markets prior to opt-in for this Campaign.

## **CAMPAIGN MECHANICS**

7. This Campaign can only be enrolled ONCE per Client.
8. This Campaign is only applicable to Live Trading account with leverage of 1:500.
9. Clients with accounts linked to PAMM, MAM and/or UM Social will not be able to participate in this Campaign.

10. Upon meeting the following conditions, the corresponding reward will be granted:

11. The reward is calculated based on tiers. Each client (User ID) is eligible to receive only the reward corresponding to the highest tier achieved where both net deposit and trading lot requirements are met during the promotion period.
12. Rewards cannot be accumulated across different tiers. Each client can only receive one reward based on the highest eligible tier achieved.
13. If a client meets the net deposit requirement but does not meet the corresponding trading lot requirement, they will receive the reward based on the highest tier where both conditions are met. The same rule applies if the client meets the trading lot requirement but fails to meet the net deposit requirement.
14. All rewards are calculated and issued in USD, with the final reward amount determined based on the corresponding reward tier achieved through eligible trading lot.
15. Upon achievement of the requirement within the Campaign period, the reward will be distributed to the Client's trading account within 14 business days after the end of the promotion period.
16. Internal transfers, balance, cash adjustments, Introducing Broker or Affiliate rebates, or commissions will not be considered as a deposit and are not eligible for this Campaign.
17. This Campaign is only applicable to trading orders with the following products: Forex, Gold, Silver, Crude Oil, Bitcoin.

18. Trading orders that are opened for products not listed in clause number 17 will not be eligible for this Campaign along with its stipulated mechanics and/or requirements.

19. The trading lot requirement will only take into account trading orders with a time interval of 10 minutes or above between opening and closing.

20. Net Deposit refers to the total amount of funds deposited into the trading account during the promotion period, minus any withdrawals made within the same period. Internal transfers between accounts under the same User ID will not be considered in the Net Deposit calculation.

Formula: Net Deposit (USD) = Total Deposit Amount - Total Withdrawal Amount

21. Clients are allowed to participate in other Campaign, Promotion and/or Offer along with this Campaign.

## **GENERAL TERMS AND CONDITIONS**

The following conditions apply to all campaigns, offers, and/or promotions unless explicitly stated otherwise:

22. All Ultima Markets' campaigns, offers and/or promotions are only available in accordance with applicable law.
23. This Campaign is not intended to alter or modify an individual's risk preference or encourage individuals to trade inconsistent with their trading strategies.
24. Clients should ensure they manage their trading account in accordance with their risk tolerance.
25. Ultima Markets will not be responsible for loss, liability or damages arising out of the Campaign participation and any technical issues, including but not limited to server issues, poor internet connection, leading to not being able to participate in this Campaign in a good manner.
26. The Client agrees that Ultima Markets' reserves the right to use all images, data, or personal information for its own promotional and marketing purposes, including all social media posts unless it is explicitly specified by the Client not to do so in writing.
27. New Live Accounts are subject to approval as per Ultima Markets' account opening procedure. Individuals who apply for an account must check their local laws and regulations before applying for an account with Ultima Markets.

28. PAMM / MAM Investor and Master are not eligible to participate in this Campaign.
29. Ultima Markets reserves the right to cancel the Client's eligibility and participation in this Campaign if the deposit is made via e-wallet/cryptocurrency channel, including but not limited to USDT.
30. Clients are not allowed to use the rewarded cash from this Campaign to hedge positions. Ultima Markets reserves the right to cancel a client's eligibility to participate in any offers, promotions or campaigns, remove the rewarded cash/bonus from their trading account, and partial/full removal of profits generated by hedging positions without notice.
31. Ultima Markets reserves the right to decline any application or indication to participate in any campaigns, offers, and promotions at its sole discretion without providing any justification or explanation.
32. Any dispute and/or misrepresentation is made in relation to the stipulated terms, shall be resolved by the Company, acting in good faith and as it shall, in its sole and absolute discretion, be deemed fit and proper. You are advised to review these Terms regularly and by your continued use of Ultima Markets website and services that you accept any such modified terms. Ultima Markets reserves the right to modify or cancel any campaigns, offers, or promotions at its sole discretion at any time.
35. Ultima Markets may cease or discontinue any of its campaigns, offers, and/or promotions at any time and at its sole discretion.

36. Ultima Markets will not be liable for any losses, costs, expenses, or damages that a client may incur in connection with this campaign, offer, or promotion and which by law may not be excluded by these Terms.
37. If these terms and conditions are translated into a language other than English, the English version will take precedence if there is a difference between the two.

## **ADDITIONAL CAMPAIGN TERMS AND CONDITIONS**

39. You must be over 18 years of age to register and apply for an account.
40. If your account is closed or suspended, Ultima Markets reserves the right to cancel the rewarded cash or bonus in your account, along with any profits made from this Campaign.
41. Ultima Markets may amend or discontinue this Campaign without prior notice to current or prospective applicants and compensation will be remunerated.
42. If Ultima Markets has reasonable grounds to suspect that you have abused or attempted to abuse this campaign, offer, or promotion to the detriment of Ultima Markets, Ultima Markets may deny, cancel, or withdraw the campaign, offer, or promotion, and either temporarily or permanently terminate your account and access to all services offered by Ultima Markets.
